BILLBOARD CONTROVERSY



On this past May 14th the NASCAR, Dodge Charger 500 was run at Darlington Raceway in Darlington, SC. As has been well documented in this publication, NASCAR has recently been doing there best to rid themselves of their Southern roots and denounce everything associated with that history. Why? Because Brian France and the "powers that be" at NASCAR think there is more money to be made up North and out West with a different fan base. With this in mind the South Carolina Division of the SCV leased a bill board (pictured above), proclaiming "Victory is Great but Honor is Greater, Defend Your Southern Heritage," and the SCV's national phone number, just outside the raceway in Darlington. Similar bill boards have been leased by the SCV near the raceway in Richmond, VA and the raceway in Concord, NC. The Darlington bill board was leased from Palmetto Outdoor Media (POM) of Summerville about a week before the race and was contracted to stay up for 15 months so as to be there for two races. Two other sign companies, Costal Outdoor Advertising and Adams Sign, refused to put our sign up at all and would not do business with the SCV. (If your ever in need of a sign remember not to do business with these two bigoted companies.)

POM leases the land their bill boards are on from various individuals and companies and the day before the race they received a call from South Carolina Central Railroad, the

SETTLEMENT REACHED IN PROM DRESS CASE

School Board elects not to go to trial

LEXINGTON, KENTUCKY -- Nearly two years after she was barred from her high school prom for wearing an evening dress patterned after a Confederate flag, Southern Legal Resource Center client Jacqueline Duty was vindicated as her former school board agreed to settle her lawsuit against it out of court.

The SLRC's local counsel in the case, Kentucky Attorney Earl Ray Neal, confirmed the settlement Tuesday, adding that the precise terms of the settlement, including the amount of damages awarded, will not be disclosed under mutual agreement by attorneys for both sides. The case had been scheduled for trial in August, 2006.

"We know this comes as a tremendous boost for Jacqueline, especially at this time," said SLRC Executive Director Roger McCredie, who noted that Ms. Duty, now a college student, faces surgery tomorrow. "She couldn't ask for a better get-well card," he said.

Ms. Duty's case stemmed from events of May 1, 2004, when she was prevented from entering the senior dance at Russell High School wearing the red sequined ball gown she and her mother had worked on for two years. The dress featured a blue and white "half-X" diagonal stripe with stars, alluding to the basic design of the Confederate battle flag. School officials termed the dress "too controversial." Following the incident, the Duty family contacted the SLRC, whose chief trial counsel, Kirk D. Lyons, together with Attorney Neal, had formed the winning legal team in another Kentucky case, Castorina v. Madison County Schools. That case overturned a school system's ban on Confederate-themed clothing.



FROM THE CHAPLAIN

Compatriots:

We had the opportunity to observe Confederate Memorial Day at Magnolia Cemetery. Many Secession Camp #4 Compatriots were in attendance as we rendered honors to the fallen. I often wonder if we recognize the origin of this event. The Battle for Petersburg, (Bermuda Hundred) took place on June 9, 1864. Petersburg was defended by a reserve force of 1000 including old men and boys when attacked by a Federal Force of 3200 troops. This force held, it delayed the fall of Petersburg for nearly ten months. The ladies of Petersburg formed the La-



dies Memorial Association on May 6, 1866 "to devise a means to perpetuate their gratitude and admiration for those who died defending homes and loved ones." It was decided by unanimous vote to make 9th of June a permanent Memorial Day. On June 9, 1865 Ladies Memorial Association member Miss Nora Davidson took a group of young women from her school to the Blandford Church Cemetery, there they decorated the graves of both Union and Confederate dead. It was during a visit to Petersburg in 1868 that Mrs. John A. Logan (wife of US Gen. "Black Jack" Logan then Senator Logan) observed this celebration. Mrs. Logan received the inspiration, which caused the National Decoration Day (later Memorial Day) to be observed on May 30 of each year. The National Memorial Day observed on May 30 supplements; it does not replace the original observance of June 9, 1864. Please consider the common origin and purpose when you plan you activities on these days.

HERITAGE WATCH

This month we have a big corporation that seems to have a huge prejudice against our Confederate Heritage. RailAmerica is a large national company the owns 42 short line railroads all over America. They are the owner of South Carolina Central Railroad in Hartsville, SC a small company that operates two short rail lines in the Hartsville area. SC Central leases land along their rail lines to sign companies such as Palmetto Outdoor Media (POM) which in turn leases bill board space to advertisers. The state SCV recently rented a bill board from POM which displayed a heritage ad with the SCV logo and a Confederate battle flag, near the Darlington raceway. The intent was to remind Southerners of their heritage and to recruit for the SCV. When the management at SC Central saw the bill board they called POM and told them to take down the bill board or they would cancel the lease on the property. Although POM did remove the sign for a day they put it back up when the SCV threatened to sue. Recently RailAmerica advised POM that they were terminating the lease on the property and that the sign had to be removed by June 14. The reason that RailAmerica's spokesman gave for removing the sign was that it is "not acceptable to the railroad." In other words our SCV logo, our flag, and our Confederate Heritage is not acceptable to the railroad. In short we are not acceptable to the railroad and neither or our ancestors! It would appear that although RailAamerica's website (www.railamerica.com) pays a great deal of lip service to ethics and equal opportunity they have no trouble violating our 1st Amendment rights or picking and choosing which groups they will treat equality and ethically. RailAmerica is just another one of those big PC, corporations, that has no trouble trampling on the rights of anyone who they decide does not fit their idea of "diversity." Corporate hypocrisy at it worse! When these kind of openly bigoted attacks against our heritage occur it is our duty and our responsibility to make sure everyone we know hears about what is happening and who these villains are. We will not let our ancestors down and we will not forget!

Remarks: 61 members and 4 guest for a total of 65 in attendance.

- SCV Charge was given by Commander Bill Baber.
- Invocation given by Sy Mabie.
- Salute to the Flags given by Color Sgt. Gene Patrick.
- The cooks were recognized for the meal of pancakes, sausage, and cantaloupe, head chef Don Pace was assisted by Perry Patrick, Don Petty, Walter Canady, and David Rentz.
- Introduction of guest which included members of the Moultrie Camp.
- The resident speaker and member of Secession Camp was Rick Hatcher, who is also the historian at Fort Sumter and Fort Moultrie. He spoke about Edwin Ruffin, who was a member of the Palmetto Guard. He actually fired the first cannon at Fort Sumter, but the first shot was a mortar round which exploded directly over the Fort. Ruffin was involved in agriculture and published a news letter on the subject. He also wrote articles which appeared in the Charleston Mercury. Following the surrender of Lee, Ruffin committed suicide, as he did not want to live under the rule of Yankee tyrants.
- Treasurers Report Woody Weatherford reported a beginning balance of \$2,362.91 with deposits of \$301.00 and 17 cents interest. Expenses were \$125.00 for International dues, \$25.00 for Division dues, \$89.26 for The Sentinel, \$14.15 for highway cleanup supplies, \$175.19 for etcher material (name tags) and \$144.00 for the Post Office box fee. Total expenses were \$572.60 which left a balance of \$2,091.48.
- Sy Mabie reported the Mickey Davis Fund had assets of \$4,692.93 of which \$1,836.00 has been authorized for the historical marker to be placed at Burdens Causeway on Johns Island, which has been approved by the S. C. Department of Transportation. This leaves a balance of \$3,856.93. He also reported that **William Heidtman** is recovering. **Bob Flow's** father, **Feb Flow** is now at home recovering from his stay in the hospital and **Jim Dickinson** is having cancer treatments.
- David Rentz reported on the Heritage Ride to be held in September. Everything seems to be going well, but we will need more volunteers at the time of the event.
- John Evans has applications for the Guardian Program and will assist anyone who is interested.
- The SCV National Convention will be held August 2-5 in New Orleans. The 6th Brigade has a bus for \$100.00 roundtrip if anyone is interested.
- Commander Baber presented an appreciation certificate to Penny Dixon, **Michael Dixon's** wife, for her help with different camp projects.
- George Nauman thanked everyone for their help with the Confederate Memorial Day Ceremony at Magnolia Cemetery. The names of over 18,000 soldiers from South Carolina were read from the Roll of the Dead, a book with their names and where they died. This began on Friday morning and was completed by ten that evening. Plenty of volunteers were present and the weather was beautiful the whole weekend. The speaker on Saturday was John Spears, who gave a talk on the history of Magnolia Cemetery and the Soldiers Burial Grounds.
- New Business: Members voted on and approved two candidates for membership, Matthew Jackson and Dr. Michael Warren.
- Three candidates, **Richard Wiggins**, **Alexander Linton**, and **Richard Richburg**, were inducted as new members in Secession Camp.
- **Bill Billingsley** was presented the SCV War Service Medal for his service in Viet Nam. He was pinned by Sy Mabie who works with Bill at the Hunley Lab.
- A motion was then made to adjourn
- The benediction was given by Sy Mabie, followed by the singing of Dixie.

owner of the land our sign was located on. SC Central demanded that our sign be removed immediately or they would not renew any of the leases that they have with POM. The reason they gave for this demand was that they feared a riot when race fans saw the sign. Why a crowd of Southern race fans, many carrying their own Confederate flags, would riot over a Confederate Heritage sign is difficult to understand. POM however, fearing loss of other properties, removed the sign the day before the race. When Division Commander Randy Burbage received word of this removal he immediately contacted a lawyer and called POM to let them know that we would not stand for our contract being violated, telling POM that they could expect a law suite. POM was also contacted by our lawyer and other SCV spokesmen. Within a short time POM called Commander Burbage back to inform him that the sign would be back up at 6 AM the next morning. The bill board was indeed back up at 6 AM the morning of the race. POM was pressured by Mr. Bob Orlando of South Carolina Central Railroad, which operates two short rail lines in the Hartsville area. SC Central is owned by RailAmerica. RailAmerica is a \$1.2 billion dollar, publicly owned, company that appears to be the real bully here. The real reason for this pressure is unclear given the reasoning of Mr. Orlando, especially since no such rioting occurred. It would appear that RailAmerica is simply bigoted towards Confederate Heritage.

On June 1 Commander Burbage received a letter from POM's attorney requesting that they be allowed to remove the sign because RailAmerica is cancelling their lease on the property and they have to remove the entire structure by June 14. The reason given for cancelling the lease is that the ad is "not acceptable to the railroad." Apparently the railroad's lease agreement with POM gives them the right to terminate the lease for almost any reason. POM is in a tough spot here but our rights are being trampled on. Commander Burbage has told POM's attorney that he will not allow the sign to be removed and he is speaking with our attorney as this article is being written. MICKEY DAVIS FUND REPORT
